Notes to Financial Results for the quarter & nine months ended December 31, 2022:

- The above unaudited financial results of the company for the quarter & nine months ended December 31, 2022 were reviewed and approved by the Board of Directors in their meetings held on February 10, 2023. The statutory auditor of the Company has carried out a limited review of the quarter & nine months ended December 31, 2022 results.
- These results have been prepared in accordance with the Indian Accounting Standards (Ind AS) prescribed under section 133 of the Companies Act, 2013 and other accounting principles generally accepted in India.
- The Company is engaged in the business of setting up of infrastructure facility by way of development of infrastructure projects, operation and maintenance of Infrastructural facilities. As such, all activities undertaken by the Company are incidental to the main business. The directors of the Company, who have been identified as being the chief operating decision maker (CODM), evaluates the Company performance, allocates resources based on the analysis of the previous performance indicators of the Company as a single unit. Therefore, there are no separate reportable business segments as per IND AS 108-"Operating Segment".
- As at December 31, 2022, the Company is having negative net worth of Rs. 1,994.42 Lacs. The Company as such has positive net current assets position and debenture service reserve account (DSRA) in accordance with debenture trust deed. Further, based on the future assured cash flows in form of annuities as per the Concession Agreement with NHAI, projected future cash outflows and projected profits during the balance concession period, the negative net worth will be recouped and it will able to meet all its present and future liabilities. Accordingly, based on the above factors no material uncertainty exists with respect to the Company continuing as a going concern.
- The Code on Social Security, 2020 has been notified in the Official Gazette on September 29, 2020. The effective date from which the changes are applicable is yet to be notified and the rules are yet to be framed. Impact if any of the change will be assessed and accounted in the period in which said code becomes effective and the rules formed thereunder are published.
- The Company is submitting the financial results for the quarter ended & nine months ended December 31, 2021 as comparatives in accordance with SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended read with Circular no. SEBI/HO/DDHS/DDHS_Div1/P/CIR/2022/0000000103, Dated July 29, 2022 and accordingly financial information relating to the corresponding quarter ended December 31, 2021, as reported in the accompanying Statement have been approved by the Company's Board of Directors and are not subjected to limited review by the Statutory Auditors.
- The Company has outstanding secured non-convertible debentures amounting to Rs. 27,893.17 Lacs as at December 31, 2022.
- The above unaudited financial results have been prepared in accordance with the amended Schedule III and accordingly previous period/year's figures been regrouped/reclassified as necessary to compare with the current period results.

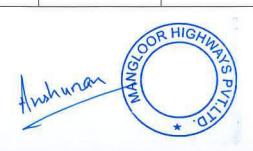
